Guest Speaker: Dr Greg Moore **Preserving old trees: essential during climate change**

Guest Speaker Dr Gregory Moore

Dr Greg Moore is a Senior Research Associate of Burnley College, University of Melbourne, where he was Principal from 1988 to 2007 and was the Head of the School of Resource Management at the University, 2002 to 2007.

Greg has a general interest in horticultural plant science, revegetation and ecology, and is particularly interested in arboriculture. He pursues an active research profile in matters that relate to trees in the urban environment, and to revegetation. He speaks regularly on topics involving tree science, cultivation and management and benefit, cost and value.



Dr Greg Moore has written two books, contributed to five others and has published over 165 scientific papers and articles. He was awarded the Order of Australia medal 2017 for services to the environment, particularly arboriculture.

Vale Warwick Exton

As we move slowly towards the end of gathering, sorting and preparing FBA history data for publication and scanning, we are extremely grateful that some funding for this project comes from FBA's successful FCC Environmental Sustainability Grant.

Stop the Great Wall of Frankston Campaign

It was extremely disappointing for many when Council adopted the FMAC Structure Plan without change in June 2023. This means for the Waterfront Precinct/Kananook Creek and the riparian corridor zone, the preferred building height is 41metres/12 storeys, which can be exceeded, subject to approval by the Responsible Authority.

As a result, in addition to regular activities, much of the FBA focus over past months has shifted to safeguarding the beach, waterway and coastal environs, from the overwhelming heights planned for new building development in this precinct.

High-rise development will cause wind downdrafts, overshadow the beach, creek, neighbouring residential properties, as well as the highway outdoor public spaces and median avenue of trees, and lead to many other adverse amenity and environmental impacts.

FBA representatives continue to work determinedly in a campaign with other local environmental groups - Kananook Creek Association, Long Island Residents Group, Mornington Environment Association and Port Phillip Conservation Council, with the aim of securing lower building heights for the Waterfront Precinct.

Two waterfront high rise applications are under appeal at the Victorian Civil and Administrative Tribunal (VCAT). In early July 2023, the Minister for Planning issued a temporary planning control, setting a mandatory height of 3 storeys for this waterside area until the end of October and proceedings at VCAT have been put on hold.

In the interim, the combined groups are continuing to work to make a similar height control permanent. However, they are contending with a very vocal cohort who support high rise developments at the waterfront.

Foreshore Working Bee Activity

FBA'S 2023 Department of Energy, Environment and Climate Action (DEECA) grant project is almost complete with 5,000 tubes planted and many weeds dispatched!

Preliminary work on a new DEECA Port Phillip Bay Fund project has begun. Plant orders have been placed and ground work begins late March 2024. Weeding and planting will continue north of the area currently being worked on.

Sincerest thanks to our volunteers and Frankston City Council. We appreciate your assistance in the effort to conserve our natural history for future generations, whilst reducing foreshore erosion.

The protection and preservation of our Port Phillip Bay foreshore is of paramount importance. Please come along and do your bit for the environment.

Further memories of the past

Concurrent with sorting through over 40 years of FBA records and memories, reminiscences from a recent trip to the War Memorial in Canberra by current Committee Member Bob Graham, has reminded us of the contribution to Australian art, made by past FBA member Raymond Ewers.

Raymond Ewers was born in Wyalong NSW in 1917, educated at Frankston High School and then spent a year as a jackeroo. He won a scholarship to train as a commercial artist at the Working Men's College (now RMIT) Melbourne. Eminent Australian sculptor Leslie Bowles, selected Ewers for a 5-year apprenticeship. He worked as his assistant on two memorial sculptures: King George V and General Sir John Monash in Melbourne.

Ewers enlisted in the AIF as a sapper in 1941. On recommendation from Bowles, he was transferred to the Military History Section in 1943 and appointed as an official war artist with the rank of lieutenant. During the early stage of his commission, Ewers worked in the Memorial's Melbourne office and in his own studio in Frankston. His primary task was to research and create the sculptural elements of the Second World War dioramas.

He was commissioned to collect materials from New Guinea and Borneo for the construction of dioramas. Between 1943 and 1958, Ewers produced 32 dioramas depicting events from the 2nd World War. From the late 1940s until the 1960s, he executed commemorative sculptures for the Memorial. 22 are held in the art collection. Of significance is the impressive Australian Serviceman, now a feature of the Memorial's sculpture garden.
